

TULSI AND MIKE GABBARD SHOULD NOT BE TRUSTED

Tulsi Gabbard became my U.S. Congresswoman in 2013. For many on the tiny island of Kaua'i, her ascension to Washington D.C. was positive and instilled hope. Tulsi was a young, dynamic local leader. Voted for Tulsi, supported her and donated to her campaign over the years.

Election 2016 was significant. Tulsi served as VP to Democratic National Convention. Tulsi also was an ally of Bernie Sanders. Hillary and DNC obstructed Bernie in 2016 primary. Also supported Bernie. Hillary frustrated Bernie Bros. We viewed Tulsi as a national hero for exposing the "cheating" of Bernie. Tulsi resigned her VP position and spoke out. DNC chair Debbie Wasserman Schultz resigned in disgrace; Donna Brazile, CNN analyst, was fired.

I championed my Congresswomen in defense. Bernie Bros defected, voted Trump, and Trump was elected. The Democratic Party never forgave Tulsi. Her political career with Democrats was over. Democrats don't tolerate criticism and retaliated.

Spoke highly of Tulsi's courage over the next years. Wrote to her. Received only automated or canned responses. Learned I cannot trust, we should not trust, Tulsi to be there for us.

REFUSED TO STAND UP FOR HEALTHCARE INSURANCE REFORM

Tried repeatedly to get a personal meeting with Tulsi. Americans are today, were in 2020, enraged with the healthcare insurance industry. Tulsi had promised to "sit down with anyone, anywhere." I offered to meet her anytime, anywhere. Asked for just 30 minutes. Had a revolutionary healthcare proposal: Medicare for Anybody. ¹Tulsi refused to help Americans.

Served New Mexico's workers compensation for about a decade. Was also trained by the University of New Mexico School of Medicine to battle the opioid epidemic. Trained by Johns Hopkins School of Medicine in pandemic response. My plan would have been helpful to our nation and could give Tulsi a winning platform for Americans during a challenging public health crisis. Tulsi and team refused my requests. Mike Gabbard refused my requests to arrange a meeting with Tulsi.

Tulsi's career with Democrats ended with Election 2020. Together, we forcefully battled Kamala Harris. Tulsi looked stronger. History remembers Joe Biden selected Kamala. Believe Tulsi made a critical mistake not jumping on the healthcare plan. Bernie's pursuit of Medicare for All was simply a bridge too far in America. Medicare for Anybody was the bridge. Tulsi missed the opportunity.

Tulsi's judgment in Election 2016 — in my opinion — was poor regarding fake accounts. She cost herself a possible VP position refusing to meet and discuss my healthcare proposal in 2020.

IGNORED CONCERNS ABOUT FAKE FACEBOOK ACCOUNTS

Tulsi refused to help Americans with social media concerns. Had forwarded a memo to Tulsi's team, Aug. 26, 2016 (Appendix 1), about FAKE accounts on social media and destabilizing impact this behavior had on local election activity. Team Tulsi responded 9.2.2016 by informing me they passed my email to Tulsi. Never heard back. Hillary claimed later that FAKE ACCOUNTS had negatively impacted her campaign.

From a national security perspective, Tulsi did not take my concerns seriously. We know our community better on the small island of Kaua'i. Facebook was unable to control membership. Tulsi did not see the significance of my report. Social media is a major destabilizing force.

REFUSED TO STAND UP FOR VETERANS

Tulsi and Mike claim to support our troops. Easy to say. Actions however speak louder than words. In Hawai'i, Japanese Buddhist group, Shinnyo-en, hosts a delightful event, Lantern Floating. I've been an outspoken critic for over five years. It's not the event; it's the date.

Shinnyo-en holds their observation for civilians on Memorial Day. By tradition, Memorial Day is reserved to honor the men and women in uniform who fell while in service to our nation. Such observations are somewhat quaint and old-fashioned to most generations in the U.S. today. Who cares about parades, military flyovers and decorating graves of men and women who perished in the fight for freedom decades ago?

Mike Gabbard told our team that he supported our goal: Shinnyo-en would hold their observation on Sunday. The military observation would be on Monday, Memorial Day. Together, *laulima*, we would create Memorial Weekend in Hawai'i. End conflict and further harmony and peace.

Mike broke his promise. Neither he nor Tulsi would assist. Tulsi paraded around the nation championing Veterans. Tulsi refused my requests to stand up for Veterans lying at rest in Hawai'i.²

Tulsi has shown a propensity now to NOT take on tough issues; to not stand for America's values. Likely the political punishment she suffered speaking out in 2016 changed her from a champion of ethics and justice to a political opportunist who now "goes along to get along."

Tulsi's aunt, Caroline "Sina" Sinavaiana-Gabbard, acclaimed poet and teacher, was brutally murdered in Samoa May 2024. In an 2022 interview with *The Independent*, Sina warned that her niece's career is all about the pursuit of power:

Once again I find my niece's apparent penchant for parroting extremist toadies such as Tucker Carlson and vile 'strongmen' such as Vladimir Putin, to be problematic and deeply troubling.

I wrote to Tulsi and Mike expressing my sadness that Tulsi was drifting closer to Hannity and MAGA. In June 2024, predicted Tulsi would become Trump's VP.³

REFUSED TO HELP A LONG-TERM LOYAL CONSTITUENT

Reached out to my Congresswoman due to observed incompetence and cruelty by the state's primary electricity provider, Hawaiian Electric Co. The company appeared poorly-managed. Six-months later, an outside financial group demanded corporate board renewal.

On August 8, 2023, faulty HECO equipment and negligent management ignited the tragic fire that wiped historic Lahaina town and incinerated at least 102+ human beings including keiki. The disaster was *Biblical* in nature.

Tulsi's leadership could have forced HECO to review their safety protocols. Tulsi refused my endless requests for help. In August 2018, Hawaiian Electric Co. offered me a short-term contract for an IT position on O'ahu. Relocated. My 90-day review from my Japanese American manager was glowing:

YOU have been a great asset to our team and it is your personality and humble nature that makes all of us so comfortable working together. We have had contractors on the DBA team before, but never with the synergy and positive energy that you bring with you. I believe you have had the greatest influence in our success and glad that we selected the right contractor. You have definitely made your mark here at HECO and have set the bar

very high for future contractors! Thank you for being you...keep doing what you do... keep that good karma flowing! **Lori Yafuso, HECO IT Department Manager**

HECO offered me a permanent position. Due to disability, I'm prescribed medical cannabis. My treatment plan calls for medication in the evening to reduce pain so I can sleep restfully. When HECO extended the offer, informed HECO HR. led me to believe my medication was permitted. HECO fired me two weeks later February 25, 2019, due to my medication.

Reached out to my Congresswomen. Tulsi ignored me. Pleaded with her father, Mike Gabbard. I'm a White male in Hawai'i. Hard to land professional jobs. Being fired for a drug violation at 61-years-of-age was career ending in conservative Asian-dominated O'ahu culture. Needed to clear my name. I had not violated any laws or policies. Had been ethical and honest. HECO labeled me a drug criminal. I was radioactive.⁴

After constant pleading with both Tulsi and Mike, Mike granted me a meeting. He was visibly disturbed by the wrongful termination. Asked for Tulsi's assistance. A letter from her could make all the difference. Denied.

In addition, my position was mission critical to HECO. We were upgrading server security across O'ahu, Maui and Big Island, and faced a hard deadline. Removing me put the people of Hawai'i at risk. The IT team needed my professional skills. The wrongful termination endangered the company and public.

Tulsi refused me. Continued my efforts with Mike. We became professional friends. When Tulsi announced her run for president, I joined her team. Not only did I believe Tulsi could be a strong candidate, hoped serving her directly would assist my goal of clearing my name.

Worked hard for Tulsi. I'm a skilled political advocate. My PhD work is political science, economics and healthcare. Served governors in Idaho during my high school and undergraduate college years. Idaho Democratic U.S. Senator Frank Church had appointed me to Air Force Academy. Ended up declining the offer. AFA told me I was too tall to fly jets. Accepted a scholarship instead to play basketball.

Hosted Senator Church's International Symposium on foreign policy for a number of years. Senator Church received national acclaim for his hearings on U.S. intelligence — "one of the most important oversight investigations ever undertaken by Congress into covert operations by the US intelligence community."⁵ We had a strong professional relationship.

During my PhD program at the University of New Mexico, my criminal justice research inspired Republican Governor Gary Johnson to propose legalization of recreational cannabis in 2000. We lost. Colorado and Washington legalized 2012. New Mexico legalized 2021 ... 21 years later. The delay egregiously allowed cartels to gain greater foothold in the state, particularly in the Albuquerque area. Crime has exploded — more guns, drugs and human trafficking due to the failure of elected officials. Looking back, I've been on the right side of history.

Tulsi stands for legalization of cannabis. She echoes many of my values. Tulsi stood up to Democrats cheating democracy in 2016, and suffered their wrath and retaliation. I had spoken out about HECO's corruption and incompetence. The corporation and friends retaliated against me. Just as Tulsi had become a pariah in the Democratic Party, I am a pariah in Hawai'i.

Thought Tulsi would care about me, about the issues that are important to Americans like me. She didn't. However, I wanted to see Tulsi succeed. As an athlete and coach, we focus on the BEST in players. Did the same with Tulsi. I was an affective advocate during her presidential run. Team Tulsi held online meetings (see Appendix 2). Made a number of suggestions that were adopted. Tulsi spoke a couple times. Tulsi never spoke with me directly.

Tulsi Gabbard LIED to me ... a dedicated professional who was assisting her campaign and our nation. Her father Mike Gabbard LIED to us ... many supporters of Veterans who were counting on him.

Yet Angela Kaaihue spammed our group, not with respectful political discussion, but with Hate Speech. Myself and others immediately noted our disapproval; she intensified her hateful rhetoric.

After some time and significant outrage by our members, the group administrator banned her. She then proceeded to make a FAKE account and re-registered with the group. Posing as a third-party, she continued her hateful and uncivil rhetoric. Again, myself and others noted our disapproval; she again intensified her nasty rhetoric. And, we were able to get her banned for a second time. Angela Kaaihue then created a third account. Same hateful, nasty rhetoric; same response by members; yet this time, the administrator shut down the entire group due to her nasty behavior. We had over 3,500 members. Due to Angela Kaaihue, we have lost our connections to each other. We have lost a useful and important forum for local discussion.

Angela Kaaihue destroys American freedom and democracy. The hatred, bigotry and deception destroys friendships and civil activity. She claims to be a "christian" but clearly is a false prophet. She charges others for being the Devil or Satan. Yet it is clear she is the Dark Angel.

Aloha Amaury,

Appreciate the training today. Excellent start. Look forward to assisting any way your team needs. I apologize in advance for what will be perceived as an arrogant and know-if-all-attitude. I first voted in Jimmy Carter's campaign. I'm a senior political scientist, business intelligence professional, and survey research / public opinion specialist.

Quick example. As a PhD candidate, measured public opinion for DOE Waste Isolation Pilot Project (WIPP) in southeastern New Mexico. This is a storage facility for spent radioactive components. We discovered words matter. If the media described the facility as a waste "repository," public opinion was relatively favorable. If we changed one word — referring to the facility as a waste "dump," attitudes were far less supportive.

In training today, you pointed out Tulsi's distinguishing position relates to *Regime Change* and national defense. All of us are political junkies. We are comfortable with the term. People who will ultimately elect Tulsi are not. You recognize we must speak to our audience. You likely have heard this before but most Americans are comfortable with 9th grade vocabulary. This does not slight intelligence or suggest people aren't smart. Americans simply use different terminology.

Regime Change is confusing. Confusion intimidates. People don't like to admit they don't know; they won't ask what this means. In many cases, they will simply nod their head, as if they understand. This effects motivation. In such a scenario, the individual is less likely to follow through registering.

In advertising, we think of the process as: Interest — Recall — Motivation. Volunteers must generate interest. The voter must be able to recall at a later time. They must be motivated to sign-up and donate \$1.

Objective One

People watching early debates are political junkies. Their vocabulary is more complex. To get to 130,000 registered supporters, volunteers must speak to a wider audience. Vocabulary during Donor Challenge (DC) needs to match audience. I include a two-page illustration. Bill Clinton succeeded, as he recognized, "It's the economy." *Regime Change* is a lofty ideal. It's a number of steps from the voter's wallet.

I've taken a graphic published by Peter G. Peterson Foundation. You've seen this. U.S. spends more on defense than next seven nations. Let's call this Trump's Plan. Tulsi isn't going to further military adventures around the world. She will maintain world's strongest military — but invest in America at home as well. Tulsi's Plan offers a balanced approach. I refer to this as Compassion with Wisdom.

One key is to maintain discipline focusing solely on Trump. Debate 2 turned into a circular firing squad. Biden and Booker are still sniping at each other. Voters hate this. What they say — or what is said about them — will be used by Republicans if they ultimately represent the party.

Appendix 2

My graphic compares Tulsi's Plan to Trump's Plan. We can discuss if you like, but the point is to be somewhat self-explanatory. Trump continues a bloated, wasteful Military Industrial Complex. Tulsi spreads America's wealth across many needed areas. We're still stronger than China — and nobody questions China's formidable might. We also invest in other areas. Tulsi INVESTS in America.

Objective Two

To qualify for the September and October debates, candidates must achieve a minimum of 2% support in four qualifying polls. Tulsi has established herself in foreign policy. She needs an attractive domestic issue — something that distinguishes her.

I'm a healthcare economist. I have an alternative to Medicare For All. The political reality is MFA will not pass Congress at this time. There are insufficient votes in the U.S. Senate. I realize Tulsi supports this proposal. Doing so keeps her in the pack.

I actually have a **better way** for America considering economic, social and political constraints. I promise you this proposal will increase Tulsi's name recognition and boost her past the 2% poll minimums. The plan is exciting, fresh and innovate. National media will want to know more.

It's simple to describe, but sufficiently robust to meet America's needs. It's a game changer for Tulsi.

I don't want recognition. Not seeking a job or compensation. I support Tulsi 100% and want her in the White House. I also want to help us correct our broken healthcare system. I met a couple weeks ago with Tulsi's father. Needed him to know I'm not a kook. Didn't show him the plan. This needs to go directly to Tulsi and most trusted advisors. This plan must be treated as a confidential product and marketed efficiently to achieve maximum penetration and voter impact.

I need 30 minutes with Tulsi. I'll meet her anywhere and anytime. We can talk over breakfast, during a ride to an airport or while waiting backstage at a publicity event. I know the limitations on her time. I'm business intelligence. I put information together efficiently.
